

2020 POOL SEASON - POOL PATRON (FOR MINOR) AGREEMENT TO ASSUME RISK AND RELEASE

This Agreement to Assume Risk and Release contains important information about the conditions under which a minor may enter and use the Hampton Chase Recreation Association pool and the surrounding areas. Please read each paragraph carefully and sign below if you agree, on behalf of the minor, to each of the terms and conditions in this Agreement to Assume Risk and Release.

The Hampton Chase Recreation Association pool and pool area encompasses the property located at 5492 Ashleigh Road, Fairfax VA which include the pool and the clubhouse and shall be referred to below as the "Pool Area". Although **Hampton Chase Recreation Association** (the "Association") and its contractors have taken steps to attempt to reduce the risk of spread of the COVID-19 virus in the Pool Area, the use of the Pool Area and a user's presence in the Pool Area still creates risks that the user may contract the virus. **Therefore, as a condition to a minor person's access to the Pool Area during the 2020 Pool Season, the minor's parent or guardian, on behalf of the minor, must agree on behalf of the minor that the minor is voluntarily assuming the risk of contracting the COVID-19 virus because of his/her use of or his/her presence in the Pool Area. If you do not wish to the minor to assume such risks, you may not allow the minor to use or be in the Pool Area.**

By signing this Agreement, you acknowledge on behalf of the minor the contagious nature of the COVID-19 virus, and on behalf of the minor, you voluntarily assume the risk that the minor may be exposed to or infected by the COVID-19 virus while on site in the Pool Area and that such exposure or infection may result in personal injury, illness, permanent disability, and death of the minor.

You understand that the risk of becoming exposed to or infected by the COVID-19 virus in the Pool Area may result from the actions, omissions, or negligence of yourself, the minor and others, and you have fully explained those risks to the minor.

You voluntarily agree, on behalf of the minor, to assume all of the foregoing risks and to accept sole responsibility for any injury to the minor including, but not limited to, personal injury, disability, death, illness, damage, loss, claim, liability, or expense, of any kind, that the minor may experience or incur in connection with his/her presence in the Pool Area or participation in Pool Area activities ("Claims").

I, THE UNDERSIGNED, AM THE PARENT OR GUARDIAN OF THE MINOR NAMED BELOW, AND ON BEHALF OF THE MINOR, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF THOSE RELEASED HEREBY OR OTHERS AND ASSUME FULL RESPONSIBILITY FOR THE MINOR'S USE OF OR PRESENCE IN THE POOL AREA.

On my behalf, and on behalf of the minor, to the extent permitted by law, I hereby release, covenant not to sue, discharge, and hold harmless the Association's Board of Directors, and its agents, management and contractors and their employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating to the minor's use of or presence in the Pool Area.

I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Association's Board of Directors, its management and contractors and their employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in Pool Area activities or presence in the Pool Area, to the full extent permitted by law.

I HAVE READ THIS AGREEMENT TO ASSUME RISK AND RELEASE, I FULLY UNDERSTAND ITS TERMS, I UNDERSTAND THAT I, FOR MYSELF AND ON BEHALF OF THE MINOR, HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND I SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT ON BEHALF OF THE MINOR.
